## Membership Dues Categories & Definitions

**Regular Member.** Any person who is admitted to the practice of law in the State of New York shall be eligible to be a Regular Member of the Association.

**Participating Member.** Any person who is (a) admitted to the practice of law in any jurisdiction other than the State of New York, or (b) does not reside, have an office or practice in the Seventh Judicial District and does not work in the Courts in the Seventh Judicial District shall be entitled to be a Participating Member.

**District Member.** Any person who is admitted to the practice of law in the State of New York and whose primary place of business is located in the counties of Cayuga, Livingston, Ontario, Seneca, Steuben, Wayne, and Yates, shall be eligible to be a District Member of the Association.

**Regional Member.** Any person who is admitted to the practice of law in the State of New York, whose primary place of business is located in the counties of Cayuga, Livingston, Seneca, Steuben, Wayne, and Yates, and who is a member of the bar association of the county in which their primary place of business is located shall be eligible to be a Regional Member of the Association.

**Retired Member.** Non-judicial members who have retired and have filed a certification with the Chief Administrator of Courts, pursuant to 22 NYCRR 118.1(g).

**Honorary Member.** Regular Members whom the Board of Trustees, in its discretion selects, or who qualify pursuant to a policy adopted by the Board of Trustees, shall become Honorary Members of the Association.

**New Admittees & Law Students.** Attorneys admitted to the practice of law who are in their first year of admission (New Admittees), law school students, and those awaiting admission after passing the State Bar exam, as well as those awaiting results of the Bar exam. For New Admittees this member classification shall end on June 30 in the year following the year of admission.

**Affiliates.** Paralegals, legal assistants and law administrators, and law school graduates who are not admitted in any jurisdiction shall be eligible for Affiliate Status. In addition, the Board of Trustees shall have power to grant Affiliate Status upon such other persons as the Board of Trustees in its discretion may decide would benefit from or assist the Association by such Affiliate Status.
