7/13/17- Retiring from the Practice of Law- a practical, realistic CLE that will focus on the process of retiring from the practice of law in Rochester. Attendees will be walked through the process in checklist fashion with clear explanation of who to contact and what procedures are necessary to close down a practice without violating ethical rules. (.5 Ethics, 1.5 Practice Management credits)

7/20/17- Mental Health and Attorney Discipline- This program offers information on mental health and its all too common role in the Attorney Grievance Process from both a psychologist and from counsel to the Attorney Grievance program. (2 credits Ethics)

7/27/17- Casemaker Legal Research Training- Casemaker is a benefit of your Monroe County Bar Association membership so you need to know how to get the most out of it. The training class will introduce the user to the scope of the content included with Casemaker (cases and codes from all 50 states, all federal courts and much more).
